"What is a Health Spending Account?"

A Health Spending Account (HSA) coverage is broader and more flexible than a traditional benefits plan. That means there are not as many restrictions (yay!).

A traditional plan generally has a limit on expenses - for example, only 80% of dental services would be reimbursed, up to a maximum dollar amount in a set time, or only \$50.00 is reimbursable per massage visit.

However, with an HSA, there's no set percentage of coverage or dollar limit for certain services. There are also no deductibles that need to be reached before eligible expenses are reimbursed!

The only limit to the amount reimbursable for eligible expenses is the amount of funds available in the HSA.

An HSA is also an awesome complement to existing coverage to reduce out of pocket costs for medical expenses! If someone is partially covered by another plan, they can claim amounts not reimbursed by that plan through their HSA - so, they're getting full reimbursement of eligible expenses!

There are fantastic tax benefits with an HSA. A Plan Sponsor or Captain's company can deduct the contributions and fees related to the HSA as a business expense. For Plan aka Crew Members, the contributions made to the Health Spending Account from Plan Sponsor is tax free to the Member.

If HSA Plan Members were to pay for health expenses outside of an HSA, it means they'd have to file for such expenses on their tax return. Using the CRA's Medical Expense Tax Credit (METC) requires that a family reaches a certain (rather high!) healthcare expense spending threshold before the credit can be used.
